AN EXHIBIT entitled "Woven From the Soul, Spun From the Heart: Textile Arts of Safavid and Qajar Iran, 16th - 19th centuries" will be held at the Textile Museum in Washington DC, November 7, 1987-January 29, 1988. The 350-page exhibit catalogue was edited by Carol Bier, who also contributed 2 chapters to it.

CALL FOR PAPERS - After a panel session on Iranian exiles (those Iranians who, because of the 1979 revolution, have stayed away from Iran, by choice or otherwise) at the 1985 annual meetings, it was suggested that a special issue of IRANIAN STUDIES be devoted to that subject.

However, it soon became obvious that the subject is very complex and it was decided to publish an edited book which would allow more scope both in topics and in length. Therefore, anyone who is seriously interested in contributing an original paper on the subject of Iranian exiles, including those who have already

A CONFERENCE entitled "The Role of Research in Reconstruction", organized by the Iran Research Center for the Reconstruction of War-Damaged Areas, will be held at Shiraz University, October 3-5, 1987.

THE IRANIAN REVOLUTION DOCUMENT SET of the National Security Archive contains over 3500 declassified and unclassified US government documents, many released under the Freedom of Information Act. The documents are comprehensively indexed on a database whose records contain over 20 distinct fields of information. documents include cable traffic between the US Embassy in Tehran and the State Department in Washington from 1963 to 1979, with strong emphasis on the years 1978-79. The collection is particularly strong on the political developments during the Iranian revolution and the hostage rescue mission.

The objective of the Archive is to have the entire collection copied onto microfiche so that it can be made available to institutions and libraries. A hard-bound, comprehensive, cross-referenced index and finding aid will accompany the microfiche. The Archive plans to produce a number of other sets on the Middle East. The Executive Director of the Archive is Scott Armstrong, and Eric Hooglund is the Senior Analyst.
