

# REPORT FROM THE TREASURER

The year 2000 was financially a record year for the Society: record expenses, record revenues, and a record deficit! It is normal to expect both higher revenues and higher expenses during the year of the biennial conference, which this time was much larger than the previous ones. Accordingly, the conference costs were much higher at about \$36,500, but so were the revenues and consequently the conference nearly broke even with a deficit of only a few hundred dollars.

Our recurrent expenses were somewhat higher than in 1999 and we ended the year about a thousand dollars above the projected budget of \$40,000 even though some individual line items were substantially different from the projected levels. The largest discrepancies were in the cost of the office of the Executive Secretary, that of the Web site, and the expenses of the Newsletter. Our office costs will be significantly higher in 2001 while the other two items will most likely return to more normal levels.

On the revenue side, there were significant shortfalls compared to last year's figures and the budgeted amounts. Both individual and institutional dues fell substantially. The drop in institutional subscriptions is particularly worrisome. Gifts were down about 50% from last year

The deficit, at over \$12,000, is much larger than what we expected and it has wiped out nearly half of the surplus built up over the pervious two years. The Society is not in immediate danger of a cash crunch, but the situation is clearly not sustainable for long. We have to trim our expenses and we must renew our efforts to solicit donations and to expand our membership.

# LETTER FROM THE EDITOR

Volume 32, No. 4 (Fall 1999) was published and delivered to the mailer on March 15. If you have not already received it, you should shortly. This issue represents both the promise of the journal and the challenges it faces. For the first time since the founding of the journal in 1968 four separate issues have been published for a given volume. Volume 32 is not the largest volume the journal has published (that was the 1974 landmark issue Sudies on Isfahan that came out in two double issues totaling more than 700 pages) but at 635 pages plus index it represents the kind of journal members of the Society deserve. It also is an indication of the productivity of scholars in the field. Despite a fairly high rejection rate (about 2/3 of all articles received) there is clearly a substantial amount of excellent scholarship being produced on Persian/Iranian themes. And we want to make Iranian Studies the journal of choice for researchers.

In an effort which often feels Farhadean, we work to reduce the backlog. This is a challenge to say the least. I have given up making predictions as to when we might achieve correspondence between the year on the calendar and the year on the journal spine. In the past twelve months, six issues have been produced and that should be cause for hope, but with a look at the year date on the latest number (Fall 1999) depression settles in. You should know, though, that you will not be shorted on your subscriptions. The policy of the Society is that members for a particular year will receive the journal issues for that year regardless of when they are published, and subscribers for the current year will receive all issues published in that year irrespective of the dates they carry.

The "head offices" of the journal seem to be in continual flux. Katsuyo Motoyoshi, assistant editor extraordinaire, moved on to better things at the Modern Language Association after nine months here. (I hope we are not becoming a training program for the MLA; first Linda Thomas and now Katsuyo have been lured away.) Nick Roberts, a graduate student here at NYU, has come back to help out in the interim and I am pleased to say that Dr. Rosemary Stanfield-Johnson, a Safavid specialist and a professional editor, has also signed on as part-time associate editor.

In an effort to improve both the technical quality of the journal and to address fulfillment issues (subscribers who don't get their journal), we have been exploring the possibility of assigning the right to publish the journal to a commercial publisher. Should such a change occur, we do not expect that individual subscription rates will change. Institutional rates would most certainly rise. We will keep you informed in future newsletters as to the progress of the negotiations.

I reiterate my perennial plea. Please send to the journal work that you think is appropriate to it. We are a peer-reviewed journal so submission does not mean
