#### **Research and Related Administration**

I have conducted a number of research studies on gender-based violence in Iran as well as young Diaspora Iranians in the UK.

Having an expertise in Sharia law, I have conducted qualitative research within the Muslim and European contexts on gender-based violence, focusing on both, cultural and structural violence and domestic abuse. For example, I have written successful research proposals on the work of Sharia Councils in the UK as part of an ESRC Large Grant as well as a successful research funding from the Global Challenge Fund looking at Gender and Displacement with the Muslim communities of the UK and Iraqi Kurdistan. Being an expert in international comparative research, I led the qualitative part of an externally funded (DAPHNE) comparative European research project between five countries (England, Italy, Bulgaria, Norway, Cyprus), looking at 'Safeguarding teenage intimate relationships online and offline'.

The above research projects have led to various high-quality publications and conference papers.

## **Teaching Responsibilities**

• I am the current Programme Director of Childhood Studies, which has 6 pathways including with a significant range of responsibilities such as liaising with both academic and support colleagues across the University; ensuring the delivery of a first-class student experience across the 3/4 years of the programme of study; academic planning and management of staff and resources; marketing and overseeing Open Days, Widening Participation and public engagement; and developing, with colleagues, robust systems to ensure the wellbeing of students on this programme. Also since 2008 I have contributed to a range of programmes and courses at both undergraduate and postgraduate level at the School for Policy Studies and

have convened at least three units each year. Having an in-depth insight into Muslim context, I have developed new units and lectures and incorporated them into some of the units at undergraduate and post graduate levels. These have enriched the childhood studies, Social Policy, MpolRes and MPP programmes, highlighting the importance of contextual and intersecting issues such as location, race, ethnicity and religion
