### Letter to SIS Members

There are more scholars around the world today who are working on subjects concerning Iranian societies, history, culture, language, literature, religion, and economy than ever before. The variety of changes brought about by the Iranian Revolution, both within Iran and outside, however qualitatively conceived, continue to grab the attention of scholars, journalists, political analysts, government officials, and the public throughout the world. It is my personal feeling that the academic community in the United States and elsewhere must conscientiously continue to promote scholarship and education on Iranian subjects, as well as promote the linkages within the academic and nonacademic communities in order to maintain a communication which fosters a genuine understanding of Iranian societies, past and present. The Society for Iranian Studies can serve as a strong force in the academic and professional communities today in several ways. First, it can provide an institutional forum within which dialogues and linkages may occur. Second, it can promote or perhaps even sponsor individual, joint, or institutional projects. Third, it can disseminate information through the Journal and the Newsletter, as it has done in the past, to a variety of interested audiences.

As Executive Secretary of the Society for Iranian Studies, I would like to call upon you to help me accomplish the goals we have established as a Society over the next few years. These goals, which concern the functions and activities of this organization, are as follows: first, to expand the membership of the society to include as many individuals and institutions as possible; second, to raise funds in order to support the ongoing activities of the Society, and to

increase those activities if possible; and third, to expand the Newsletter in a way that reflects membership needs and interests and that promotes greater understanding of Iranian societies.

The Society for Iranian Studies is one of a handful of professional organizations whose membership consists of individuals either interested in or professionally devoted to the study of Iranian society and culture. Our membership has expanded over the past twenty years of our existence to over 420 individual members and over 190 institutional subscribers. However, this expansion has yet to reflect the potential membership in the United States and abroad. In order to increase our membership we plan to recruit new members through mailings, contacts at conferences, and advertising. Here, current members can be extremely helpful in promoting the Society for Iranian Studies at professional conferences and seminars.

The Newsletter is our lifeline to members in the field of Iranian Studies. It reaches those members in the academic world and those who are active in other professions. Although it functions primarily to inform its membership, it also is a voice which reflects the richness and diversity of ongoing inter-

ests, activities, and events concerning Iranian societies, past and present. With this in mind, I plan to continue to include the useful information which has been included in past issues of the Newsletter. I also plan to expand our coverage of publications and activities abroad as well as to include one short special interest article per issue beginning with the Spring/Summer 1988 issue. Please continue to send information on professional news, seminars and conferences, books published. awards, and so on. If you wish to submit a short article (1-2 pages) please send me a brief abstract. Our aim is not to publish lengthy scholarly articles, since this is the domain of the Journal, but rather to further promote Iranian Studies and provide a conduit of communication for research and events on the area. The short articles will allow for more in-depth coverage of individual research projects, events, and news items.

The Endowment Fund which was begun in 1985 has reached nearly \$19,000, which yields an income of approximately \$1,000 per year. I set \$24,000 as our goal for 1988, and appeal to you once again to contribute to this fund in order to help assure the future financial well-being of our organization.

## **Editor's Report**

After a long delay occasioned by editorial transition and a complete transformation of the design and production of Iranian Studies, the journal is now ready to make up for lost time. A triple-length issue on "Iranian Studies in Europe and Japan" planned and edited by Rudi Mathee and Nikki Keddie will be mailed in April. This will complete the 1987 volume year. A double length issue on Central Asia planned and edited by Robert McChesney should be mailed in June. This should put the journal back on schedule. The Editor is most grateful for the patience and support of the membership during this transition period.

# Council Meeting

The Annual meeting of the SIS Council took place on Saturday, November 14, 1987 at the Sheraton Hotel, Baltimore, Maryland. The Executive Secretary, Habib Ladjevardi, reported that 56 new members joined the Society in 1987. The total membership has increased to 552; there were 421 individual members and 177 institutional members as of November, 1987. We now have 13 life members, each of whom have paid \$500, and the Endowment/Life Membership Fund now stands at \$18,755, producing an income of \$1,000 a year.

At the Council meeting Jo-Ann Gross, of Columbia University was elected Executive Secretary for a three year term, and Annabelle Sreberny-Mohammadi, of Queens College was elected Treasurer for a three-year term.

After the election, Jo-Ann Gross conducted the balance of the council meeting, during which time Val Moghadam, Brian Spooner, and Hamid Naficy were nominated for the office of council member for the 1988-1990 term. Mohammad Ali Jazayery and Michael Hillmann were selected as the

members of the 1988 Election Committee.

During the Council meeting, it was decided that we establish contact with the European Association for Iranian Studies and with foreign representatives at universities abroad in order to expand our network and increase membership. In a discussion concerning advertising, it was suggested that we ask publishers to place advertising in IRANIAN STUDIES, send new rate sheets to publishers, and contact booksellers and university presses. Annabelle Sreberny-Mohammadi has agreed to take on the job of advertising development.

In a discussion concerning the expansion of the NEWSLETTER, Carol Bier volunteered to write a small column on Arts in the Islamic World which would include museum exhibitions, conferences, and public lectures. Richard Bulliet reported that with the new printing methods now being employed for the Journal and Newsletter, we could expand the Newsletter with no great cost increase.

## Treasurer's Report

The long-term financial picture of the Society continues to improve as efforts over the past several years to create an endowment fund have produced a steady increase in the principle of the fund. As of 30 September 1987, the total amount in the fund was nearly \$19,000, very nearly at our goal of two years ago to reach \$20,000 as a first stage. The several dozen members, especially Council members, who have contributed deserve warm thanks.

Income from this fund fluctuates but even the brightest prospects would yield an income under \$1,000. Our immediate goal is to:

- Achieve the \$20,000 figure with one last push during the 1987 MESA conference.
- 2. Settle on an investment strategy that would provide reliable income.

Long term goals are to continue to search for means to increase the fund through innovative tactics evolving out of the deliberations of the new Executive Committee. A \$50,000 endowment would meet our administrative expenses and the Newsletter, allowing for continued subsidies of membership fees.

The picture in terms of operating funds remains less rosy than the endowment fund. With payment of current printing bills and other expenses associated with it, we will have nearly exhausted our unrestricted assets. This does not mean that we will be insolvent since incoming dues and institutional subscriptions will adequately meet our ongoing expenditures, particularly as the new Executive Committee has been exploring means of reducing production costs for the Journal and the Newsletter. But our operating funds need to be supplemented.

## News About Members

Hooshang Amirahmadi published four articles in the Spring, 1987: "Non-Capitalist Way of Development," in Review of Radical Political Economics; "Dynamics of Provincial Development and Disparity in Iran, 1956-84," in Third World Planning Review; and "Destruction and Reconstruction: A Strategy for the War-Damaged Areas of Iran," in International Journal of Disasters Studies and Practice; and "Tehran: Growth and Contradiction," in Journal of Planning Education and Research.

Habib Ladievardi is currently Associate Director of the Center for Middle Eastern Studies at Harvard University. He recently completed The Iranian Oral History Project, a six-year effort to record the recollections of people who played key roles in recent Iranian political history. The project comprises 126 interviews, ranging in length from one to 43 hours, with a total of 794 hours of tape. Nearly all have been transcribed, amounting to a almost 18,000 pages. Interviews that are not restricted are available to researchers at Houghton Library, Harvard University, and the Bodleian Library, University of Oxford, as transcriptions or in cassette form. A reference guide to the collection is available for purchase at \$3.00 each.
